Located in North America, the United States of America is a federal republic made up of 50 states. 48 of these states make up the landmass between Mexico and Canada, while Alaska is separated from the US by Canada and Hawaii is located in the mid-Pacific. The landscape varies across the large country from tropical beaches in Florida to peaks in the Rocky Mountains, from rolling prairie lands and barren deserts in the West to dense wilderness areas in the Northeast and Northwest. Interspersed throughout are the Great Lakes, the Grand Canyon, the majestic Yosemite Valley, and the mighty Mississippi River.

The United States is a highly developed/advanced mixed economy



The U.S. economy is by far the largest economy in the world. The United States is a highly industrialised country with high levels of productivity and the use of modern technologies.

The American agricultural sector is without doubt one of the world's largest, Nevertheless, agriculture only accounts for 1% of GDP and employs 2% of the workforce

The industrial sector contributes to 17.9% of GDP and employs 19% of the workforce. the country is also the world leader in the aerospace and pharmaceutical industries. Thanks to its abundant natural resources, the United States has become a leader in the production of several minerals and has been able to maintain diversified production. The country is the world's largest producer of liquified natural gas, aluminium, electricity and nuclear energy. It is the world's third-largest oil producer and, for several years, has also been developing shale gas extraction on a large scale. In terms of value-added, the U.S. is the second-largest manufacturing nation in the world behind China.

The American economy is essentially based on services: the tertiary sector accounts for more than three-fourths of GDP (77.6%) and employs 79% of the country's workforce. A large portion of GDP is composed of finance, insurance, real estate, rental, and leasing sector.




Foreign Direct Investment




- In 2022, SAR 76573.44 million in FDI stock was recorded, higher by 14.5% compared to the previous year.
- In 2022, the value of the Foreign Direct Investment (FDI) Inflow was SAR 9109.48 million, while the FDI Outflow reached a value of SAR 624.76 million. These amounts resulted in an FDI Net Inflow of SAR 8484.72 million, higher by 34.7% than the previous year.


1st partners in GCC countries. UAE makes up 39.6% of GCC's total trade with United States.

United States & GCC Countries total trade volume







USA Imports from GCC Countries, in million US\$








Top trade categories between USA & GCC Countries

UAE makes up 39.6% of GCC total trade with USA



In 2023, the export value of United States to UAE US\$ 24857.04M, which represents 78.3% of the total trade with UAE. The main export categories have been Vehicles; other than railway or tramway rolling stock, Machinery and mechanical appliances, Electrical machinery and equipment and parts thereof, Aircraft, spacecraft, and parts thereof, and Natural, cultured pearls; precious, semi-precious stones.

The value of total imports from UAE was US\$ 6870.28M which represents 21.7% of the total trade with UAE. The main categories were Aluminium and articles thereof, Mineral fuels, mineral oils and products of their distillation, Commodities not specified according to kind, Iron or steel articles, and Machinery and mechanical appliances, boilers.





Saudi Arabia makes up 37.9% of GCC total trade with USA




In 2023, the export value of United States to Saudi Arabia US\$ 13872.81M, which represents 45.7% of the total trade with Saudi Arabia. The main export categories have been Vehicles; other than railway or tramway rolling stock, Machinery and mechanical appliances, boilers, Aircraft, spacecraft, and parts thereof, Electrical machinery and equipment and parts thereof, and Optical, photographic, cinematographic, measuring.

The value of total imports from Saudi Arabia was US\$ 16509.36M which represents 54.3% of the total trade with Saudi Arabia. The main categories were Mineral fuels, mineral oils and products of their distillation, Fertilizers, Organic chemicals, Commodities not specified according to kind, and Iron or steel articles.


United States had a negative trade balance with Saudi Arabia of US\$ -2636.54M in 2023.



Qatar makes up 8.5% of GCC total trade with USA




In 2023, the export value of United States to Qatar US\$ 4658.19M, which represents 68.6% of the total trade with Qatar. The main export categories have been Aircraft, spacecraft, and parts thereof, Machinery and mechanical appliances, boilers, Arms and ammunition; parts and accessories thereof, Vehicles; other than railway or tramway rolling stock, and Electrical machinery and equipment and parts thereof.

The total imports from Qatar were US\$ 2130.46M, representing 31.4% of the total trade with Qatar. The main categories were Mineral fuels, mineral oils and products of their distillation, Fertilizers, Aluminium and articles thereof, Commodities not specified according to kind, and Inorganic chemicals; organic and inorganic compounds of precious metals.





Kuwait makes up 5.9% of GCC total trade with USA





The main export categories have been Vehicles; other than railway or tramway rolling stock, Mineral fuels, mineral oils and products of their distillation, Machinery and mechanical appliances, boilers, Optical, photographic, cinematographic, measuring..., and Electrical machinery and equipment and parts thereof.

The value of total imports from Kuwait was US\$ 1780.81M which represents 37.9% of the total trade with Kuwait. The main categories were Mineral fuels, mineral oils and products of their distillation, Commodities not specified according to kind, Organic chemicals, Ores, slag and ash, and Dairy produce; birds' eggs; natural honey.





Oman makes up 4.5% of GCC total trade with USA





The main export categories have been Vehicles; other than railway or tramway rolling stock, Machinery and mechanical appliances, boilers, Natural, cultured pearls; precious, semi-precious stones, Aircraft, spacecraft, and parts thereof, and Mineral fuels, mineral oils and products of their distillation.

The value of total imports from Oman was US\$ 1759.46M which represents 48.6% of the total trade with Oman. The main categories were Plastics and articles thereof, Mineral fuels, mineral oils and products of their distillation, Aluminium and articles thereof, Natural, cultured pearls; precious, semi-precious stones, and Commodities not specified according to kind.





Bahrain makes up 3.6% of GCC total trade with USA





The main export categories have been Aircraft, spacecraft, and parts thereof, Arms and ammunition; parts and accessories thereof, Electrical machinery and equipment and parts thereof, Commodities not specified according to kind, and Machinery and mechanical appliances.

The value of total imports from United States was US\$ 1231.36M, which represents 42.3% of the total trade with Bahrain. The main categories were Aluminium and articles thereof, Natural, cultured pearls; precious, semi-precious stones, Mineral fuels, mineral oils and products of their distillation, Plastics and articles thereof, and Textiles, made up articles; sets; worn clothing.

United States had a positive trade balance with Bahrain of US\$ 444.88M in 2023.
